

## DISABILITY UNIT DEFENDS WORKER'S RIGHTS

Working for extended periods of time had always been difficult for Chelsea resident John Hancock. He was hit by a car as a child, and the accident left him with a traumatic brain injury and limited coordination. Now 42 years old, John had received Supplementary Security Income (SSI) benefits most of his life. Then, ten years ago, he found a job he liked and did well at the airport transporting people with disabilities. He notified the Social Security Administration (SSA) of his successful employment, and they informed him that his case would be reevaluated in nine months.

Over the next few years, John received several letters from the SSA notifying him that his benefits were being increased because of his work activity. Six years after he started working, John received another letter from SSA. It stated that he had been earning too much money to receive benefits, and that he should have stopped receiving checks years earlier. SSA claimed they had overpaid John \$41,000, and they now wanted him to pay back that impossible sum.

After months of frustrating appeals to SSA, John came to Community Legal Services And Counseling Center. CLSACC's Housing and Disability Attorney, **John Froio**, presented John's case to a judge, who waived the \$41,000 overpayment. Freed from such a massive burden, John was able to continue providing for himself. He is still working at the airport and loves his job.

## CLSACC'S DISABILITY UNIT

CLSACC's Disability Unit works to foster independence and stability in the lives of low-income people with physical and mental disabilities. The Unit is staffed by one part-time attorney and serves non-English speakers and those who are homeless or homebound who have difficulty applying for disability benefits and negotiating the administrative process. Besides substantial retroactive payments and monthly benefits, the impact of successful legal representation is profound and goes beyond providing income. By becoming eligible for SSI/SSDI (Supplemental Security Income/Social Security Disability Insurance) recipients become eligible for health care coverage, rehabilitative and educational services, transportation vouchers and utilities discounts.

In better economic times, some of these individuals can find minimally paying jobs, but during a down economic period like the present, employment opportunities for this population are non-existent, making access to disability benefits crucial for subsistence living. During 2008 the Unit assisted 112 disabled clients by providing legal advice, referral, or representation to help them obtain or retain disability and related benefits, including health care. The Unit also provides consultation, technical support, and training for community-based agencies such as the *Cambridge Commission for Persons with Disabilities*, the *Cambridge Economic Opportunity Committee*, *Cambridge Health Alliance*, the *City of Cambridge Office of Veterans Affairs*, the *Guidance Center*, *Homestart*, and *On the Rise*.
